	ocommittee updates:	<u>Transportation Subcommittee:</u> The most recent meeting was held				
-Transportation: Larissa		September 7 th . 167 community members filled out the survey with LANTA				
Kimmel		and Carbon Transit (residing from Palmerton, Lehighton, Jim Thorpe, and				
		Nesquehoning and a few from Slatington). Results showed that people				
		frequently travel to Whitehall, Allentown, Palmerton, and Lehighton for				
		things like shopping, grocery stores, and medical care. Individuals primarily				
		found out about the survey through word of mouth, and they are looking at				
		travel times primarily in the morning and afternoon. 50% of the individuals				
		that filled out the survey were aware of transportation in Carbon County,				
		which means half of those individuals don't know anything about it. With				
		this information, this gives transportation more opportunities to educate				
		the community about services provided.				
		The Carbon County Commissioners have agreed to fund the purchase of				
		two new busses that have the technology to support real time tracking and				
		head signs. They are projected to be up and running by Spring 2023. LANTA				
		is currently working to get real time tracing for the buses so you can see				
		online where transportation is and how long it will be until arrival. There				

are also plans in the work to extend routes to Northampton and Lehigh counties. LANTA will be reaching out to bigger businesses and organizations in the area to figure out if there are additional stops that need to be made and are there some accommodations that can be made to improve the way that people get to and from work or get to and from appointments.

Transportation Ambassadors are being recruited to become well versed in transposition in Carbon County so you are able to pass on that information to others.

-Connection to Care, Education, and Services for Children: Rachael Miller and Larissa Kimmel <u>Connection to Care, Education, and Services for Children:</u> Have not met since Spring of 2022. Looking to schedule committee meeting soon. The committee will continue to work through the barriers to child services that agencies have run into as well as develop a better, stronger network.

State of the Child and Family: In the past, the report has been used for grants, getting the SHINE and Right from the Start programs started. It is also used in the court system, tracking caseloads and what the issues are through drug and alcohol, etc. The reports have also shown the use of drugs in schools, what were the drugs, the age groups, and where students were getting the drugs from. The group will also build off the Community Health Needs Assessment data from St. Luke's. Considering shifting the report to an executive summary of where the gaps are and how we again take the resources and connect those gaps.

Carbon Early Childhood Literacy: <u>Dolly Parton</u> <u>Imagination Library</u>, <u>Reach out and</u> <u>Read/Brush, Book, Bed,</u> Rosemarie Lister Talk, Read, Sing: Gina Nichols Dolly Parton Imagination Library currently has 827 children in Carbon County registered. If you need additional information, please reach out to Dana Stebelski. Reach Out and Read, which is with the Pennsylvania American Academy of Pediatrics, is a program that every time a child comes to their well visit at a St. Luke's practice in Carbon County, the entire staff is trained on how to engage families and how important it is to talk, sing, read, and play with your child consistently. The visits provide the child with an age-appropriate book and a lesson on why literacy is important. The program also includes messaging on Brush, Book, Bed since Carbon is a dental shortage area. KidZone purchased a Little Free Library that is placed outside the St. Luke's Lehighton Care Now where individuals can take a book or share a book within the community.

Talk, Read, Sing encourages families and parents to connect with their kids, and to build language and vocabulary with you children. If you would like these resources in your office, please contact Gina, ginan@unitedwayglv.org, for more information. There is also a free, text

7. Self-Introductions and Agency Reports

Area Agency on Aging: Gathering resources for Grandparents Raising Grandchildren as November is Caregiver's month. Area Agency on Aging is also down 2 staff members, and the intake worker got promoted to care manager.

Carbon County Community Foundation: There have been a few new scholarships added over the summer, so if you work with families or students that are considering going to college next year or pursuing trade school, have them check out the Community Foundation website within the next month. Some applications are specific to schools, others to what the student is pursuing. If anyone is interested in becoming a member of the 20/20 circle, CCCF is having their annual meeting and grants program on November 10th at the Hofford Mill. It is free to attend, but just send Sharon Alexander an email for more information. There is also a \$3,500 20/20 circle Grant Opportunity available.

Carbon County Head Start: Enrollment has slowly increased as there are 6 Head Start classrooms open with 95 children, 15 on the waitlist, 2 PreK Counts classrooms open with 29 children, 3 on the waitlist, and 1 Early Head Start classroom serving 6 children and 21 home-based children being served with 43 on the waitlist. Staffing is a concern, which is an obstacle for opening more classrooms and serving more children.

Carbon, Monroe, Pike MHDS: Targeted Case Manager (TCM) referrals are closed for all three counties. Currently transitioning the DS department as the Supports Coordinators Organizations (SCO) is closing so there is a lot of transformation currently happening within the agency.

Children and Youth: Children and Youth participated in National Night Out. The agency is seeking foster parents so if anyone is interested, they can contact our agency for more information. Currently the agency has 114 kids in care.

CMP Systems of Care: We encourage all of you to take some time to learn how to recognize signs and symptoms of someone who is struggling emotionally and feeling overwhelmed and also get to know what your crisis services are as well. System of Care and St. Luke's is working with all of our school districts to train their crisis staff in a prepare model which is for school safety and crisis and it looks at the entire model that the district uses and offers suggestions and tips to make it a much more complete version of being able to provide safety and security in the schools as well as psychological assistance for anyone that might be impacted by any event that could occur. There will be a workshop on October 3rd and a workshop on October 11th and 12th. In addition, we have a program called Handle with Care and this is where law enforcement recognizes when there is a child on the scene: they would find out their name, their age, date of birth, and where they go to school and put a notification in the safe to say you URL link through the Attorney General's office about it. That notification goes to the schools and the schools are alerted to just handle that child with care, which means observe them, see if they're having difficulty that day or days surrounding whatever happened. The districts will not know what the occurrence was. It could have been anything from a fire, a car accident, a domestic violence situation, witnessing an overdose, anything that law enforcement is called out to. The district would then put into place the already existing levels of behavioral health supports and utilize outside supports as that youth may or may not need some additional assistance in that day. Lastly, Systems of Care hosts Trauma Trainings throughout the year, and have a few more scheduled for 2022. There will be 15 more trainers as of 2023 and will be ale to offer really rich 2-hour trainings for staff and

community members. There is also a training for parents and caregivers, as well as a training for teenagers that teaches them what trauma really is, and how it affects your body.

Department of Health: Welcome Asher Clissold to the Carbon Collaborative; Asher is the Community Health Organizer for Carbon County for the Department of Health and will be a resource for all organizations and community members. EastCentral PA AHEC: Carbon Collaborative Annual Breakfast scheduled for April 21st, 2023. AHEC is offering a discounted rate for the Princeton Review SAT ACT Prep class study. Those in High School who register through their office, can participate in the class for \$60 versus \$300. Any students you know who may be interested, please have them contact Lori at lchaplin@ecpennahec.org. The office is also hosting a virtual Search Academy on nursing on December 12th, the Search Academy is for high school students where they can interact with nursing professionals in a panel discussion and then either do a case study or hands-on activity. If you are in the nursing profession or interested in working with some students, please reach out to Lori through email. Lastly, the Community Health Worker classes are starting to fill up. If you organization is interested in receiving this training, we can tailor the hours to the needs of your staff. AHEC also offers crisis prevention intervention training as well as mental health first aid.

Independent Living Services: Doing the best to navigate the current conditions with the caregiver shortage and provide the best care we can to our older adults and the Carbon County area.

KidZone: There will be a Car Seat Check on November 22nd at the Lehighton Police Station from 10AM-2PM.

LCCC (Amber Zuber): Fall face-to-face enrollment grew by 95% at the Morgan Center. Morgan Food Share Data:

- Spring 2022: Over 79 days, 92 students received 2,103 food items and 77 toiletry items.
- Summer 2022: Over 36 days, 33 students received 345 food items and 34 toiletry items.

LCCC Receives Two-Year Grant to Provide Free CDL Training to Military and Families: Lehigh Carbon Community College is one of 19 colleges or training centers in the country and one of only two in Pennsylvania to receive a federal grant that provides funding to former and current military service

members and their families to pursue careers as commercial truck drivers. Commercial truck driving is considered a high priority occupation in the region and offers strong employment possibilities and family sustaining wages. The CDL program at LCCC teaches the knowledge and skills drivers need using a combination of classroom, driving range and on-road training. The four-week program is offered in partnership with CC Training, LLC. Experienced instructors help prepare students to take and pass their state's Commercial Driver's License test.
